The European Parliament postpones vote on TTIP recommendations

The European Parliament's president, Martin Schulz, decided yesterday evening to suspend the planned plenary vote on the EP's recommendations on TTIP (Transatlantic Trade and Investment Partnership) and to send the amendments back to the International Trade Committee of the European Parliament. Also the plenary discussion was postponed with the tight vote of 183 in favour and 181 against the delay on Wednesday morning. It is now uncertain when the vote will take place. >>>
